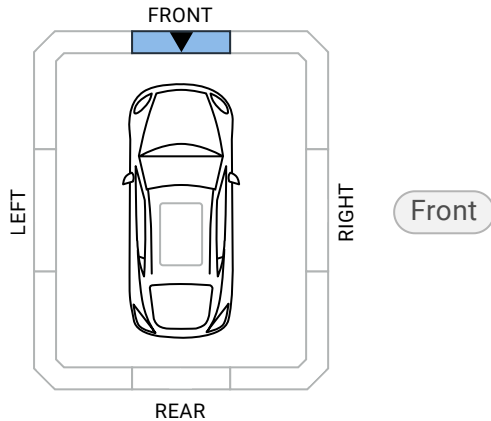

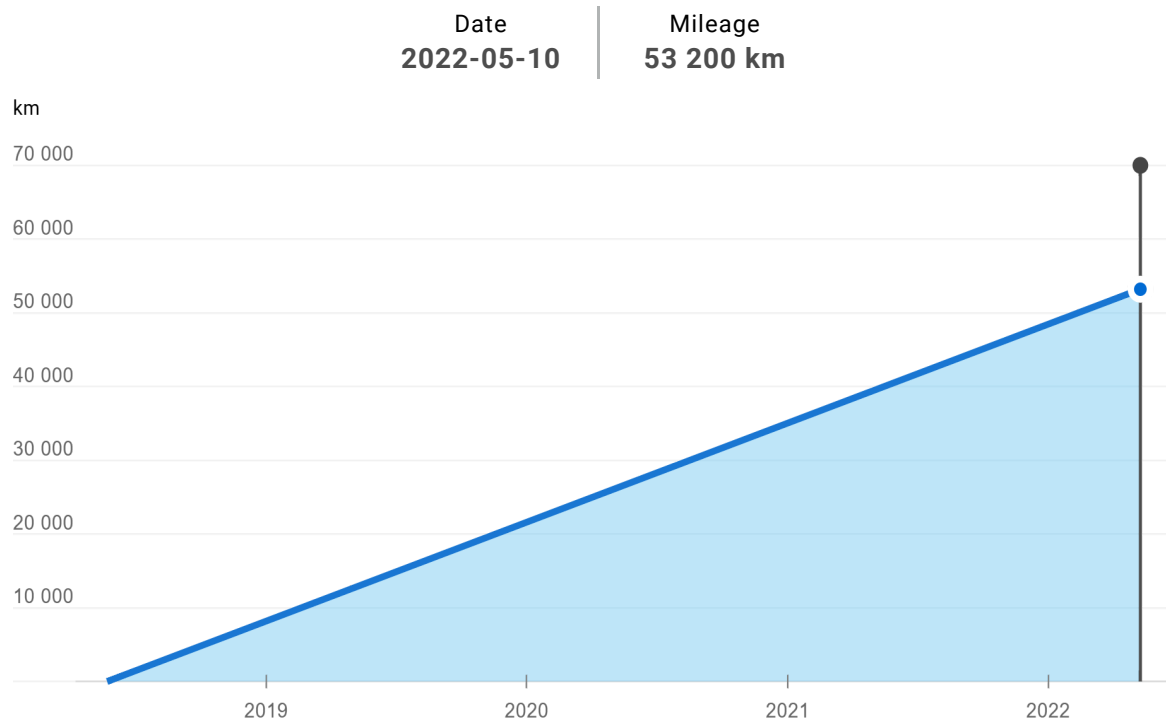

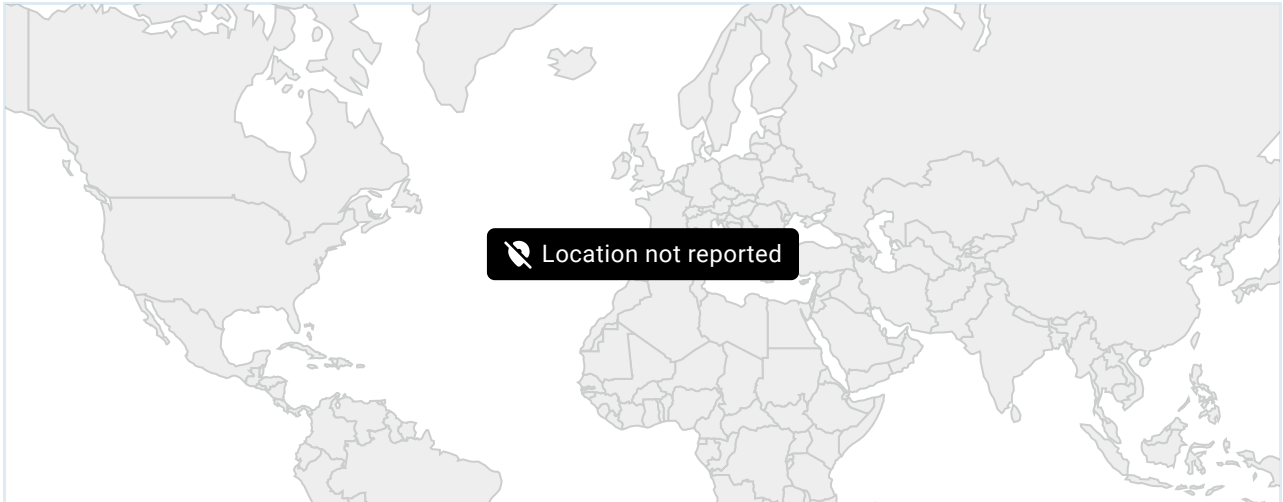

Carfax glossary

Model year
