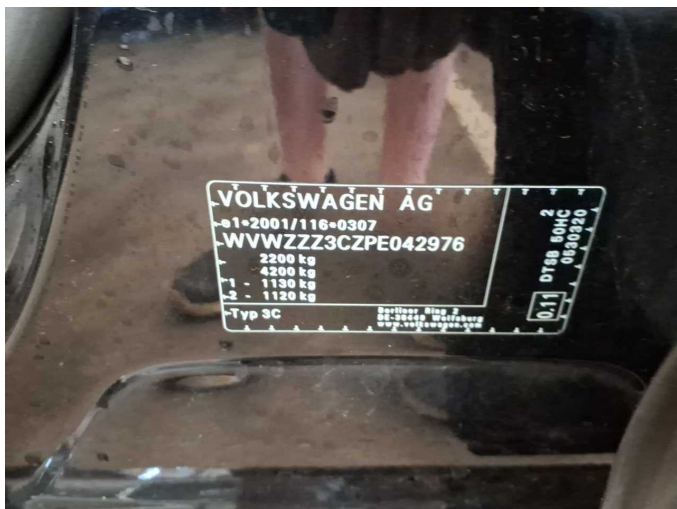


Figure 11: VIN

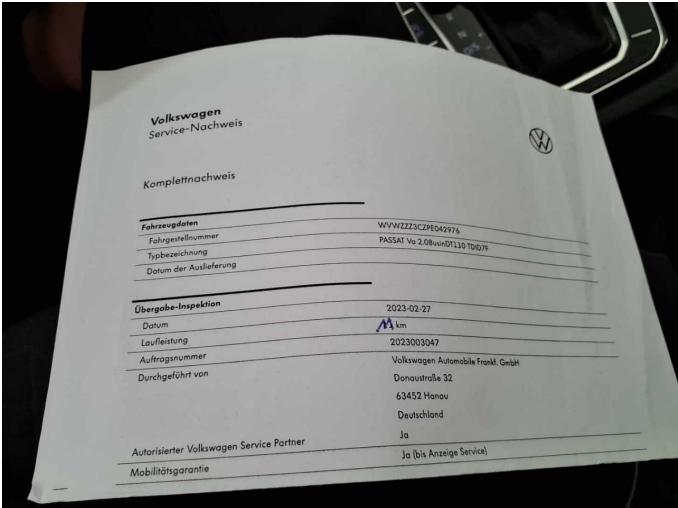


Figure 14: Documents

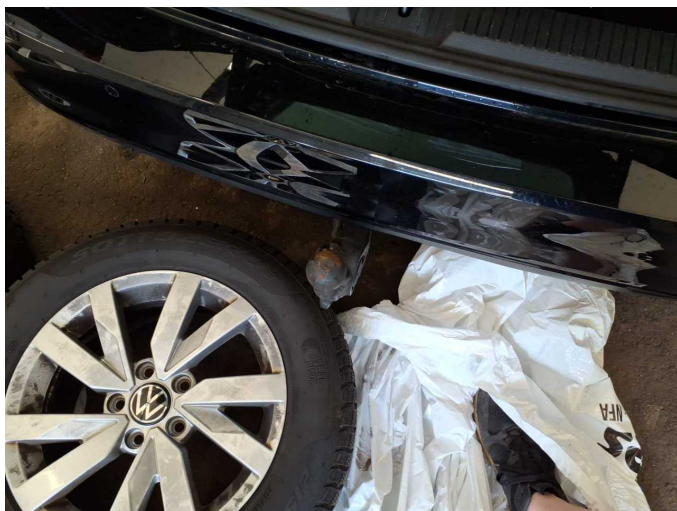


Figure 23: Misc.

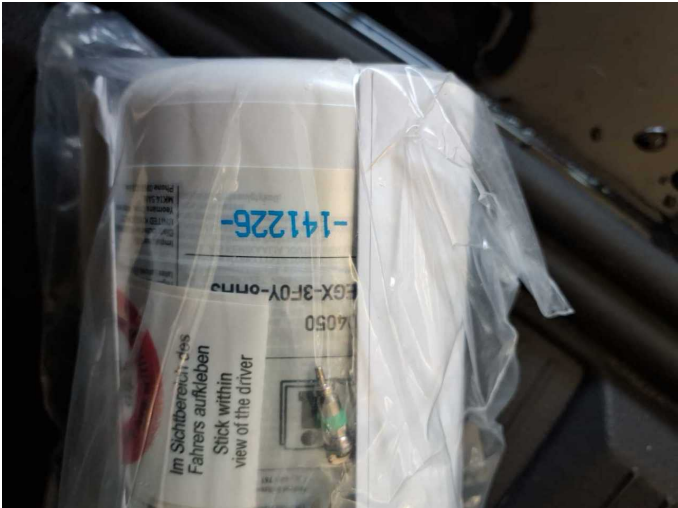


Figure 26: Misc.

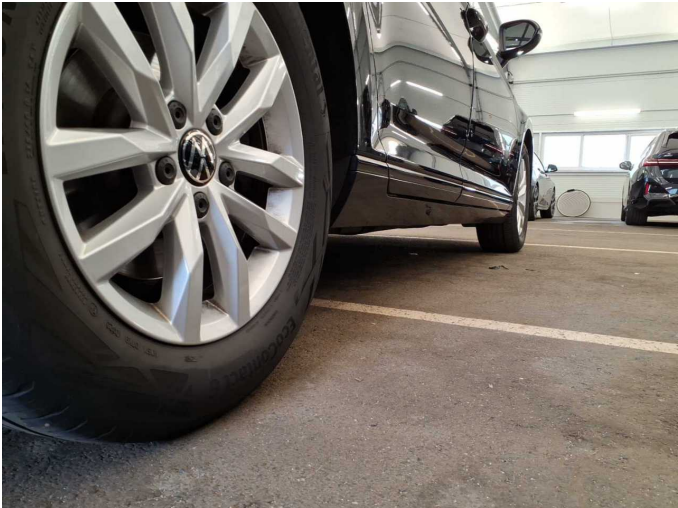


Figure 28: Misc.

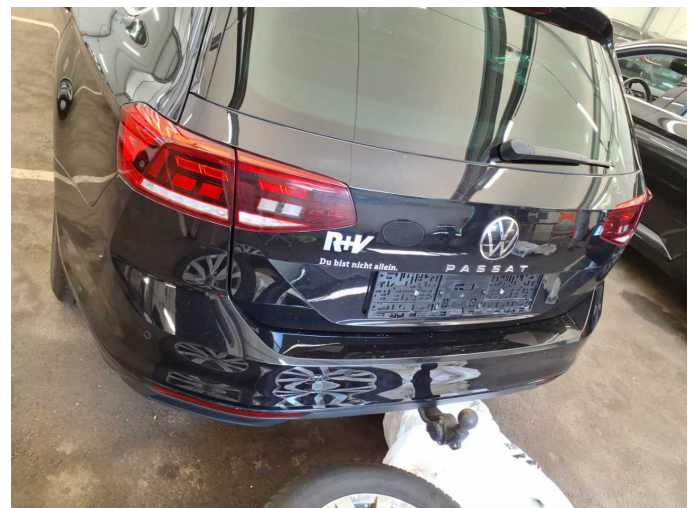
Figure 37: Misc.
